## **INDEKS VOLUM PERDAGANGAN BORONG & RUNCIT, MALAYSIA, SUKU TAHUN KEDUA 2024**

---

**Indeks volum Perdagangan borong & runcit merekodkan kenaikan  
4.9 peratus pada suku tahun kedua 2024**

**PUTRAJAYA, 8 OGOS 2024** – Indeks volum Perdagangan borong & runcit Malaysia merekodkan pertumbuhan 4.9 peratus tahun ke tahun pada suku tahun kedua 2024 untuk mencapai 155.4 mata. Ini dilaporkan oleh Jabatan Perangkaan Malaysia (DOSM) pada hari ini dalam siaran **INDEKS VOLUM PERDAGANGAN BORONG & RUNCIT (2015=100), SUKU TAHUN KEDUA 2024**. Laporan ini juga membentangkan statistik mengenai indeks volum Perdagangan borong & runcit mengikut subsektor.

Mengulas laporan tersebut, Dato' Sri Dr. Mohd Uzir Mahidin, Ketua Perangkawan Malaysia dalam satu kenyataan hari ini berkata, “Peningkatan 4.9 peratus tahun ke tahun disumbangkan oleh subsektor Kenderaan bermotor yang tumbuh 9.0 peratus kepada 132.0 mata. Ini diikuti oleh Perdagangan runcit dan Perdagangan borong yang meningkat masing-masing 5.5 peratus dan

3.1 peratus. Bagi perbandingan suku tahun ke suku tahun, indeks volum kembali positif dengan 1.7 peratus, disokong oleh subsektor Perdagangan runcit (2.4%) dan Perdagangan borong (1.7%).”

Beralih kepada prestasi mengikut subsektor, Dato' Sri Dr. Mohd Uzir Mahidin memaklumkan, “Pertumbuhan positif 9.0 peratus bagi indeks volum Kenderaan bermotor dipacu oleh Jualan komponen & aksesori kenderaan bermotor dengan 9.7 peratus. Ini diikuti oleh Jualan kenderaan bermotor (9.4%) dan Penyelenggaraan & pembaikan kenderaan bermotor (6.2%). Walau bagaimanapun, bagi perbandingan suku tahunan, indeks volum Kenderaan bermotor merosot dengan -1.5 peratus.”

Mengulas lanjut prestasi indeks volum Perdagangan runcit, beliau seterusnya memaklumkan peningkatan sebanyak 5.5 peratus bagi subsektor ini disumbangkan oleh Jualan runcit makanan, minuman & tembakau dengan 7.2 peratus. Ini diikuti oleh Jualan runcit di kedai pengkhususan (6.3%), Jualan runcit di kedai bukan pengkhususan (6.2%) dan Jualan runcit bukan di kedai, gerai atau pasar (6.0%). Dari segi perbandingan suku tahun ke suku tahun, indeks volum Perdagangan runcit naik 2.4 peratus.

Dato' Sri Dr. Mohd Uzir Mahidin turut memaklumkan, “Indeks volum perdagangan borong merekodkan pertumbuhan positif 3.1 peratus, disokong oleh Jualan borong makanan, minuman & tembakau dengan 7.3 peratus. Ini diikuti oleh Jual borong bahan mentah pertanian & haiwan hidup (6.8%), Jual borong berdasarkan kontrak atau yuran (4.4%), Perdagangan borong tanpa pengkhususan (3.6%) dan Lain-lain pengkhususan jualan borong (2.5%). Bagi perbandingan suku tahunan, indeks volum Perdagangan borong meningkat 1.7 peratus berbanding suku tahun lepas.”


“Bagi indeks volum pelarasan musim, Perdagangan borong & runcit meningkat 5.3 peratus berbanding suku tahun pertama 2024, disokong oleh semua kumpulan iaitu Kenderaan bermotor (26.7%), Perdagangan runcit (5.0%) dan Perdagangan borong (3.1%),” jelas beliau.

## **VOLUME INDEX OF WHOLESALE & RETAIL TRADE, MALAYSIA, SECOND QUARTER 2024**

---

***The Wholesale & retail trade volume index recorded a 4.9 per cent rise in second quarter of 2024***

**PUTRAJAYA, 8 AUGUST 2024** – Volume index of Wholesale & retail trade Malaysia registered a growth of 4.9 per cent year-on-year in second quarter of 2024 to reach 155.4 points. This is reported by Department of Statistics Malaysia (DOSM) in today's release of **VOLUME INDEX OF WHOLESALE & RETAIL TRADE (2015=100), SECOND QUARTER 2024**. This report also presents statistics on volume index of Wholesale & Retail Trade by sub-sector.

Commenting on the report, Dato' Sri Dr. Mohd Uzir Mahidin, Chief Statistician Malaysia in a statement today said, “The year-on-year increase of 4.9 per cent was attributed to Motor vehicles sub-sector which grew 9.0 per cent to 132.0 points. This was followed by Retail trade and Wholesale trade which increased 5.5 per cent and 3.1 per cent, respectively. For quarter-on-quarter comparison, volume index rebounded 1.7 per cent, supported by Retail trade (2.4%) and Wholesale trade (1.7%).”

*Moving on to performance across sub-sectors, Dato' Sri Dr. Mohd Uzir Mahidin added to note that, "The positive growth of 9.0 per cent in volume index of Motor vehicles was driven by Sales of motor vehicles parts & accessories with 9.7 per cent. This was followed by Sales of motor vehicles (9.4%) and Maintenance & repair of motor vehicles (6.2%). However, for quarterly comparison, volume index of Motor vehicles declined -1.5 per cent."*

*Commenting further on the performance of volume index of Retail trade, he pointed out that the increase of 5.5 per cent in this sub-sector was contributed by Retail sales of food, beverages & tobacco with 7.2 per cent. This was followed by Retail sales in specialised stores (6.3%), Retail sales in non-specialised stores (6.2%), and Retail sales not in stores, stalls or markets (6.0%). In terms of quarter-on-quarter comparison, volume index of Retail trade went up 2.4 per cent.*

*Dato' Sri Dr. Mohd Uzir Mahidin added to note that, "Volume index of Wholesale trade recorded a positive growth of 3.1 per cent, supported by Wholesale of food, beverages & tobacco with 7.3 per cent. This was followed by Wholesale of agricultural raw materials & live animals (6.8%), Wholesale on a fee or contract basis (4.4%), Non-specialised wholesale trade (3.6%), and Other specialised wholesale (2.5%). For quarterly comparison, volume index of Wholesale trade increased 1.7 per cent as compared to the previous quarter."*


*"As for seasonally adjusted volume index, Wholesale & retail trade increased 5.3 per cent as against the first quarter of 2024, supported by all groups namely, Motor vehicles (26.7%), Retail trade (5.0%) and Wholesale trade (3.1%)," he explained.*
