## INDEKS VOLUM PERDAGANGAN BORONG & RUNCIT, MALAYSIA, SUKU TAHUN KETIGA 2024

---

**Indeks volum Perdagangan borong & runcit merekodkan kenaikan  
4.3 peratus pada suku tahun ketiga 2024**

**PUTRAJAYA, 7 NOVEMBER 2024** – Indeks volum Perdagangan borong & runcit Malaysia merekodkan pertumbuhan 4.3 peratus tahun ke tahun untuk mencapai 158.3 mata pada suku tahun ketiga 2024. Ini dilaporkan oleh Jabatan Perangkaan Malaysia (DOSM) pada hari ini dalam siaran **INDEKS VOLUM PERDAGANGAN BORONG & RUNCIT (2015=100), SUKU TAHUN KETIGA 2024**. Laporan ini juga membentangkan statistik mengenai indeks volum Perdagangan borong & runcit mengikut subsektor.

Mengulas laporan tersebut, Dato' Sri Dr. Mohd Uzir Mahidin, Ketua Perangkawan Malaysia dalam satu kenyataan hari ini berkata, “Peningkatan 4.3 peratus tahun ke tahun disumbangkan oleh subsektor Perdagangan borong yang tumbuh 4.8 peratus kepada 146.2 mata. Ini diikuti oleh Perdagangan runcit dan Kenderaan

bermotor yang meningkat masing-masing 4.1 peratus dan 3.7 peratus. Bagi perbandingan suku tahun ke suku tahun, indeks volum naik 1.8 peratus, disokong oleh subsektor Perdagangan borong (3.7%) dan Kenderaan bermotor (3.2%).”

Dari sudut prestasi mengikut subsektor, Dato' Sri Dr. Mohd Uzir Mahidin memaklumkan, “pertumbuhan 4.6 peratus bagi indeks volum Perdagangan borong didahului oleh Jual borong berdasarkan kontrak atau yuran dengan 10.0 peratus, diikuti oleh Perdagangan borong tanpa pengkhususan (8.1%), Jualan borong jentera, peralatan & bekalan (7.6%), Jual borong bahan mentah pertanian & haiwan hidup (7.5%) dan Jualan borong makanan, minuman & tembakau (7.4%). Bagi perbandingan suku tahunan, subsektor ini naik 3.7 peratus berbanding suku tahun sebelumnya.”

Mengulas lanjut prestasi indeks volum Perdagangan runcit, beliau seterusnya memaklumkan peningkatan sebanyak 4.1 peratus bagi subsektor ini disumbangkan oleh Jualan runcit bukan di kedai, gerai atau pasar dengan 6.7 peratus. Ini diikuti oleh Jualan runcit makanan, minuman & tembakau (6.4%), Jualan runcit di kedai bukan pengkhususan (5.8%), Jualan runcit di gerai & pasar (5.8%), Jualan runcit bahan api kendaraan (5.4%), dan Jualan runcit barang kesenian dan rekreasi (4.1%). Bagi perbandingan suku tahunan, indeks volum Perdagangan Runcit meningkat sedikit 0.1 peratus.


Dato' Sri Dr. Mohd Uzir Mahidin turut memaklumkan, “Indeks volum Kenderaan bermotor mencatatkan pertumbuhan positif 3.7 peratus, dipacu oleh Jualan, penyelenggaraan & pembaikan motorsikal dengan 13.6 peratus. Ini diikuti oleh Jualan komponen & aksesori kendaraan bermotor dan Penyelenggaraan & pembuatan kendaraan bermotor meningkat masing-masing dengan 7.7 peratus dan 3.8 peratus. Bagi perbandingan suku tahunan, indeks volum Kenderaan bermotor kembali positif dengan 3.2 peratus berbanding suku tahun sebelumnya.

"Bagi indeks volum pelarasan musim, Perdagangan borong & runcit naik 0.3 peratus berbanding suku tahun kedua 2024, disokong oleh Perdagangan borong dengan 2.2 peratus. Walau bagaimanapun, subsektor Kenderaan bermotor dan Perdagangan runcit mencatatkan pertumbuhan negatif masing-masing dengan -1.8 peratus dan -1.1 peratus," jelas beliau.

Jabatan Perangkaan Malaysia (DOSM) telah melancarkan OpenDOSM NextGen sebagai medium yang menyediakan katalog data dan visualisasi bagi memudahkan pengguna menganalisis pelbagai data dan boleh diakses melalui portal <https://open.dosm.gov.my>.

Kerajaan Malaysia telah mengisytiharkan Hari Statistik Negara (MyStats Day) pada 20 Oktober setiap tahun. Tema sambutan MyStats Day adalah "Statistik Nadi Kehidupan". DOSM menyambut ulang tahun ke-75 Jubli Intan pada tahun 2024.

## **VOLUME INDEX OF WHOLESALE & RETAIL TRADE, MALAYSIA, THIRD QUARTER 2024**

---

***Wholesale & retail trade volume index recorded a 4.3 per cent rise in third quarter of 2024***

**PUTRAJAYA, 7 NOVEMBER 2024** – Volume index of Wholesale & retail trade Malaysia registered a growth of 4.3 per cent year-on-year to reach 158.3 points in third quarter of 2024. This is reported by Department of Statistics Malaysia (DOSM) in today's release of **VOLUME INDEX OF WHOLESALE & RETAIL TRADE (2015=100), THIRD QUARTER 2024**. This report also presents statistics on volume index of Wholesale & Retail Trade by sub-sector.

Commenting on the report, Dato' Sri Dr. Mohd Uzir Mahidin, Chief Statistician Malaysia in a statement today said, “The year-on-year increase of 4.3 per cent was attributed to Wholesale trade sub-sector which grew 4.6 per cent to 146.2 points. This was followed by Retail trade and Motor vehicles which increased 4.1 per cent and 3.7 per cent, respectively. For quarter-on-quarter comparison, volume index rose 1.8 per cent, supported by Wholesale trade (3.7%) and Motor vehicles (3.2%).”

*For performance across sub-sectors, Dato' Sri Dr. Mohd Uzir Mahidin added to note that, "The positive growth of 4.6 per cent in volume index of Wholesale trade was led by Wholesale on a fee or contract basis with 10.0 per cent. This was followed by Non-specialised wholesale trade (8.1%), Wholesale of machinery, equipment & supplies (7.6%), Wholesale of agricultural raw materials & live animals (7.5%), and Wholesale of food, beverages & tobacco (7.4%). For quarterly comparison, this sub-sector climbed 3.7 per cent compared to the previous quarter."*

*Commenting further on the performance of volume index of Retail trade, he pointed out that the increase of 4.1 per cent in this sub-sector was attributed to Retail sales not in stores, stalls or markets with 6.7 per cent. This was followed by Retail sales of food, beverages & tobacco (6.4%), Retail sales in non-specialised stores (5.8%), Retail sales via stalls & markets (5.8%), Retail sales of automotive fuel (5.4%), and Retail sales of cultural & recreation goods (4.1%). For quarter-on-quarter comparison, volume index of Retail Trade slightly increased by 0.1 per cent.*


*Dato' Sri Dr. Mohd Uzir Mahidin added to note that, "Volume index of Motor vehicles recorded a positive growth of 3.7 per cent, driven by Sales, maintenance & repair of motorcycles with 13.6 per cent. This was followed by Sales of motor vehicles parts & accessories and Maintenance & repair of motor vehicles with 7.7 per cent and 3.8 per cent, respectively. For quarterly comparison, volume index of Motor vehicles rebounded 3.2 per cent as compared to the previous quarter."*

*"As for seasonally adjusted volume index, Wholesale & retail trade inched up 0.3 per cent as against the second quarter of 2024, supported by Wholesale trade with 2.2 per cent. However, Motor vehicles and Retail trade sub-sector posted negative growth of -1.8 per cent and -1.1 per cent, respectively," he explained.*

The Department of Statistics Malaysia (DOSM) has launched OpenDOSM NextGen as a medium that provides data catalogue and visualisations to facilitate users' analysis of various data and can be accessed through <https://open.dosm.gov.my>.

The Government of Malaysia has declared National Statistics Day (MyStats Day) on October 20<sup>th</sup> each year. MyStats Day theme is “Statistics is the Essence of Life.” DOSM commemorates its 75<sup>th</sup> Diamond Jubilee in 2024.
