MALAYSIA'S EXTERNAL TRADE PERFORMANCE, JUNE 2025

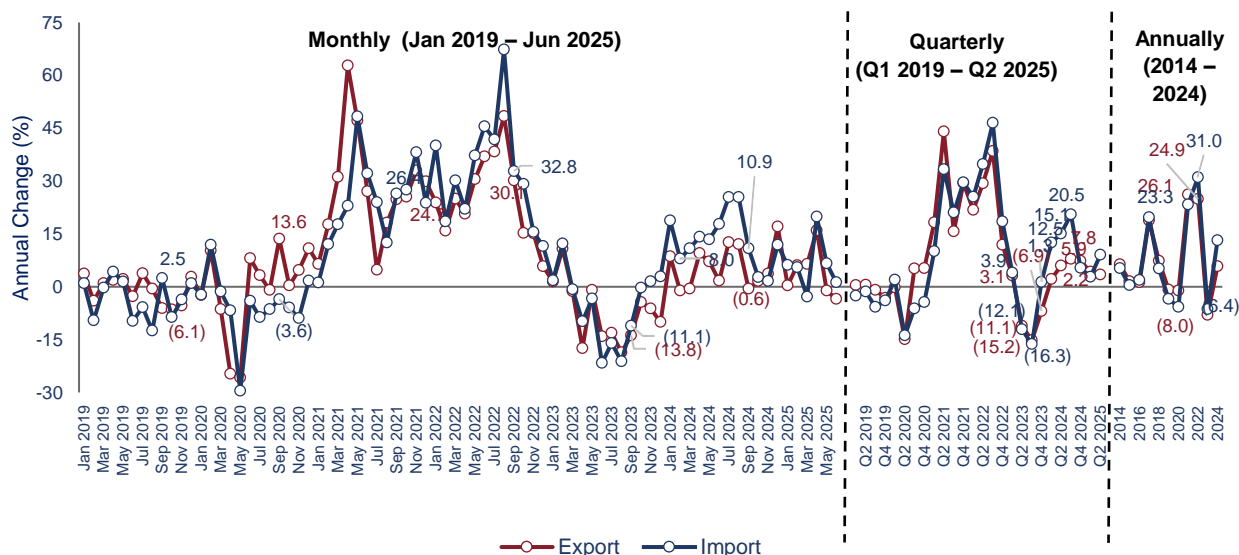
Malaysia's trade performance slightly decreased in June 2025, consistent with the decline in exports (-3.5%) and trade balance (-40.1%), year-on-year (y-o-y). Total trade downed by RM3.0 billion or 1.2 per cent, y-o-y, reached RM234.9 billion. Nevertheless, import experienced an increase of RM1.4 billion (+1.2%) as compared to the same period in the previous year.

The monthly comparison shows that exports, imports and total trade declined by 3.9 per cent, 10.1 per cent and 7.0 per cent, respectively. While, trade surplus surged by 1,030.7% from RM0.8 billion to RM8.6 billion.

For the second quarter (Q2) 2025, total trade, exports and imports recorded an expansion as compared to Q2 2024 by 6.1 per cent, 3.4 per cent and 9.0 per cent, respectively. At the same time, trade surplus recorded a contraction of 55.3 per cent.

Exports, imports and total trade for first half of 2025 rose by 3.8 per cent, 5.9 per cent and 4.8 per cent, respectively, as compared to the same period of preceding year. Meanwhile, trade surplus declined by 17.2 per cent.

EXPORTS

Malaysia's export performance in June 2025 registered a decrease to RM121.7 billion downed by 3.5 per cent

Performance of Exports

Malaysia's exports decreased by 3.5 per cent in June 2025, down from RM126.1 billion in June 2024 to RM121.7 billion.

This negative growth mirrors the 5.2 per cent decrease in domestic exports to RM95.3 billion from RM100.5 billion, accounting for 78.3 per cent of overall exports. However,

re-exports accounted for 21.7 per cent of total exports, up by 3.4 per cent to RM26.4 billion.

Moreover, a monthly comparison showed that exports reduced by 3.9 per cent or RM4.9 billion. With regards to analysis of the seasonally adjusted terms month-on-month (m-o-m), exports decreased by 10.2 per cent to RM117.1 billion.

Chart 2: Domestic Exports, Re-Exports (RM billion) and Annual Change (%)

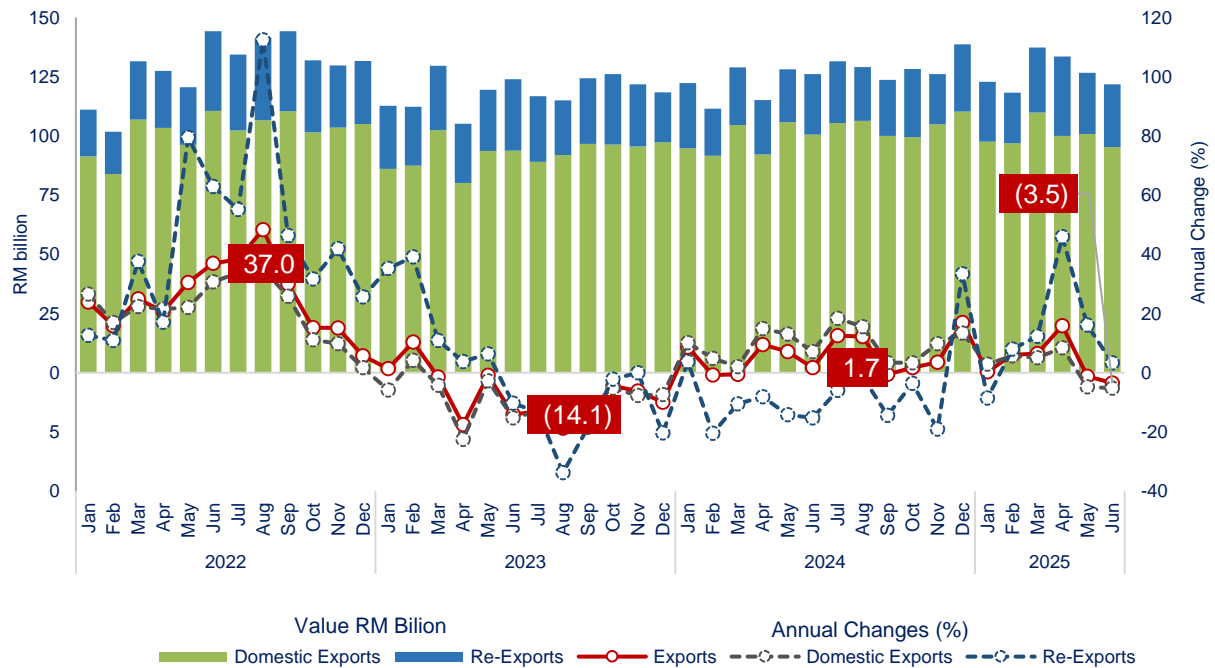
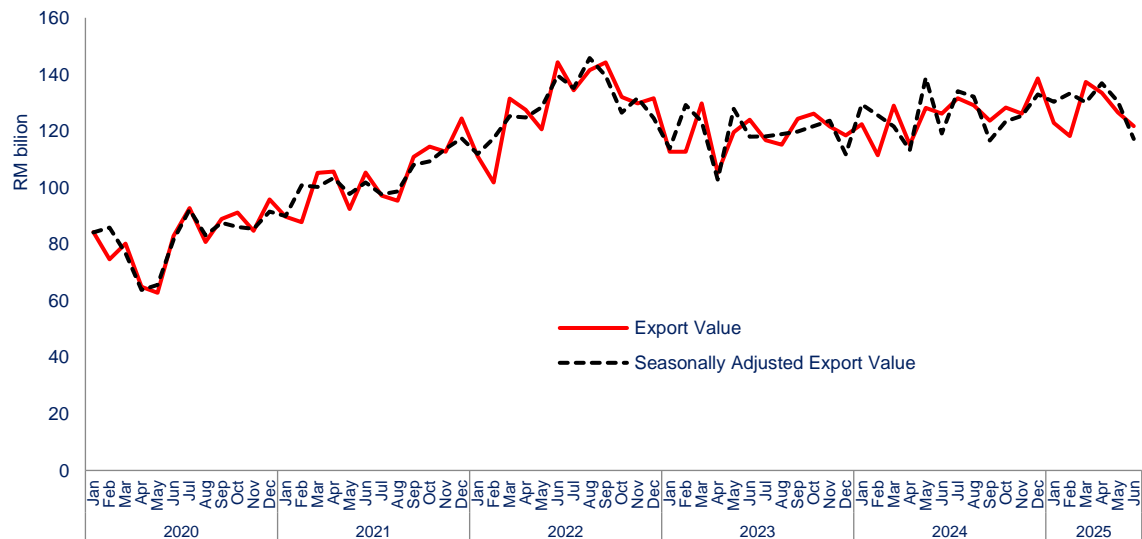


Chart 3: Actual Export Value and Seasonally Adjusted Export Value, RM billion



Export Performance for Major Country of Destination

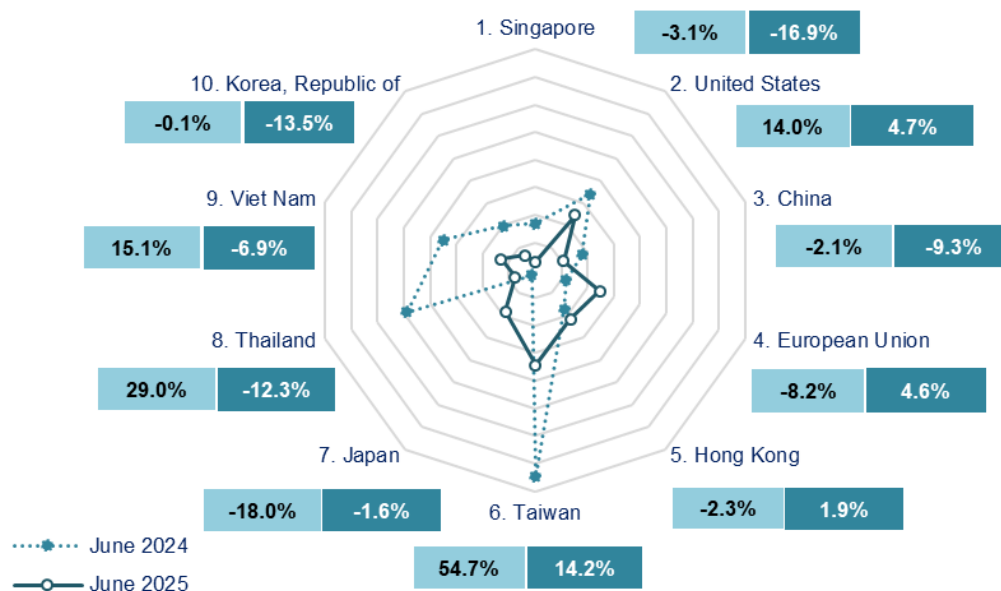
Singapore and the United States were the main destination countries with a contribution of 27.3 per cent to Malaysia's total exports in June 2025.

Singapore dominated the main destination country with a contribution of 13.9 per cent to total exports. Exports to Singapore was valued at RM17.0 billion, downed by 16.9 per cent or RM3.5 billion, y-o-y. The decline was attributable from slower exports of E&E products (-RM1.9 billion, -18.6%) and petroleum products (-RM1.6 billion, -47.8%).

Meanwhile, the value of exports to the United States which constituted 13.4 per cent of total exports worth RM16.3 billion, up by RM731.6 million or 4.7 per cent. The increase was supported by higher exports of E&E products (+RM671.2 million, +7.3%) and processed food (+RM134.5 million, +65.3%).

Out of ten major countries of destination, exports grew negatively to Singapore, China, Japan, Thailand, Viet Nam and Republic of Korea. While, the United States, the European Union, Hong Kong and Taiwan grew positively in June 2025.

Exports to ASEAN Countries

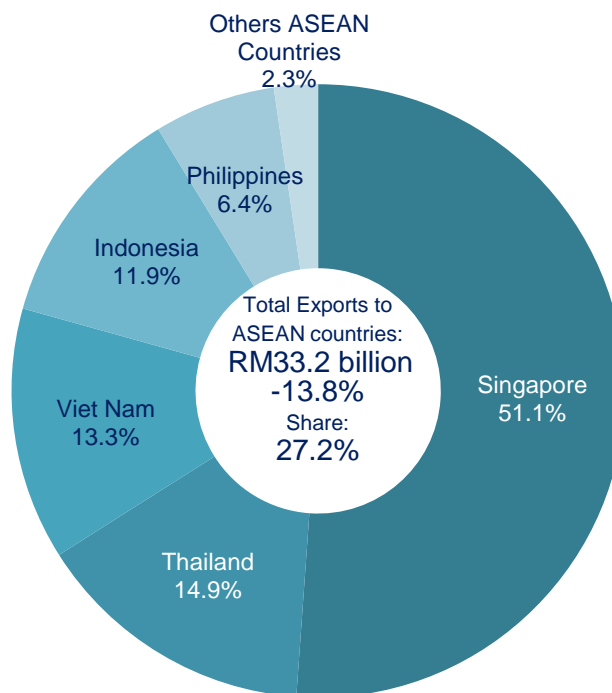
Malaysia's exports to ASEAN countries accounted for 27.2 per cent of overall exports, amounting RM33.2 billion, declined by 13.8 per cent.

The decrease was mainly impacted by the slower exports of E&E products (-RM1.8 billion, -13.1%), followed by petroleum

products (-RM1.6 billion, -24.0%) and crude petroleum (-RM929.2 million, -61.4%).

Singapore topped the ASEAN member states in overall exports, accounting 51.1 per cent, with a value of RM17.0 billion with 16.9 per cent decrease from the previous year.

Export Performance for Economic Sectors

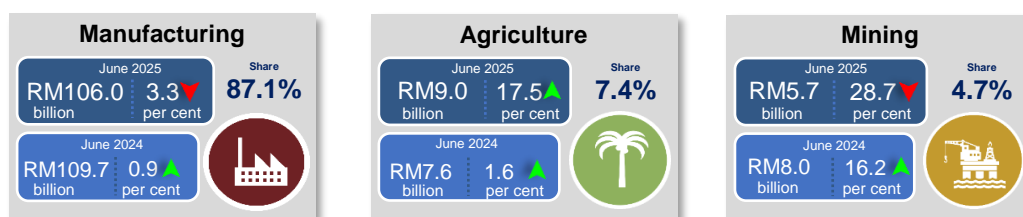
Manufactured goods exports registered a decreased by 3.3 per cent (-RM3.7 billion), accounting for 87.1 per cent of overall exports. The main causes of negative growth were petroleum products (-RM3.3 billion, -28.1%), chemical & chemical products (-RM853.7 million, -14.8%), and iron & steel products (-RM550.8 million, -21.6%).

Exports of mining products, which accounted for 4.7 per cent of total exports, fell by 28.7 per cent to RM5.7 billion, caused by lower

exports of liquefied natural gas (-RM1.2 billion, -26.5%), crude petroleum (-RM899.7 million, -42.7%), and tin (-RM62.6 million, -29.3%).

Exports of agricultural products increased by 17.5 per cent to RM9.0 billion, accounting for 7.4 per cent of overall exports. The increase was consistent with the growth in exports of palm oil & palm-based agriculture products (+RM1.4 billion, +24.7%), other agriculture (+RM79.6 million, +8.5%), and seafood, fresh, chilled or frozen (+RM22.3 million, +12.9%).

Exports of Selected Major Products

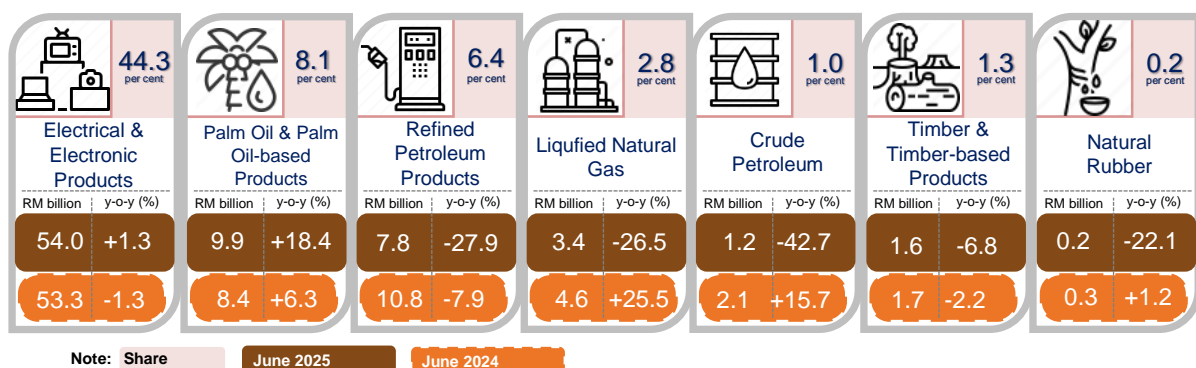
Export performance weakened in June 2025, driven by declines in the following products:

- Refined petroleum products, which accounted for 6.4 per cent of total exports, fell by 27.9 per cent or RM3.0 billion to RM7.8 billion; (-28.1%) in line with the decline in Brent oil price to RM303.2 per barrel;
- Liquefied natural gas accounted for 2.8 per cent of total exports, decline by RM1.2 billion or 26.5 per cent to RM3.4 billion. In addition, export volume and average unit value decreased by 12.5 per cent and 16.0 per cent, respectively;
- Crude petroleum, which accounted for 1.0 per cent of total exports, fell by RM899.7 million or 42.7 per cent, to RM1.2 billion despite a decrease in export volume (-20.4%) and average unit value
- Timber & timber-based products decreased by 6.8 per cent or RM117.6 million to RM1.6 billion, accounting for 1.3 per cent of total exports; and
- Natural rubber, which accounted for 0.2 per cent of total exports, decreased by 22.1 per cent or RM69.9 million to RM246.4 million. This was consistent with the decrease in export volume (-25.3%) and SMR20 rubber price (-14.1%). Meanwhile, average unit value up by 4.3 per cent.

Nonetheless, the following products recorded an improvements:

- Palm oil and palm-based agriculture products accounted for 8.1 per cent of total exports, increasing by 18.4 per cent or RM1.5 billion in line with the palm oil exports. The principal commodity in this product group, rose by RM1.1 billion, or 24.2 per cent, in accordance with the rose in export volume (+28.7%) and price of local palm oil by 0.3 per cent (RM3,969.0 per metric tonnes). Subsequently, the average unit value declined by 3.5 per cent; and
- Electrical & electronic products (E&E), accounting for 44.3 per cent of total exports, increased by 1.3 per cent, from RM53.3 billion to RM54.0 billion.

IMPORTS

Imports recorded a 1.2 per cent increase to RM113.1 billion, exceeding export growth

Performance of Imports

Malaysia's import value increased by 1.2 per cent, or RM1.4 billion to RM113.1 billion in June 2025. On a m-o-m basis, imports downed by 10.1 per cent or RM12.7 billion. According to the m-o-m seasonally adjusted terms analysis, imports decline 12.3 per cent to RM111.1 billion.

Imports by End Use increased, y-o-y, with an increase in capital goods (+21.8%) and consumption goods (+1.6%), whereas intermediate goods decreased by 1.2 per cent.

Chart 6: Imports Value (RM billion) and Annual Change (%)

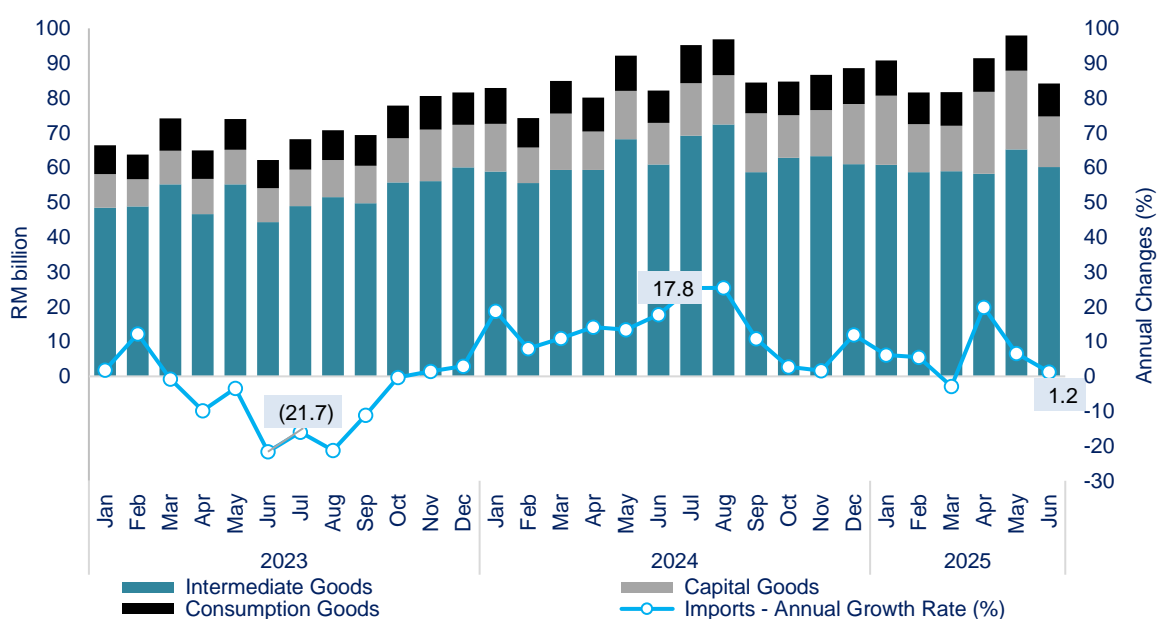
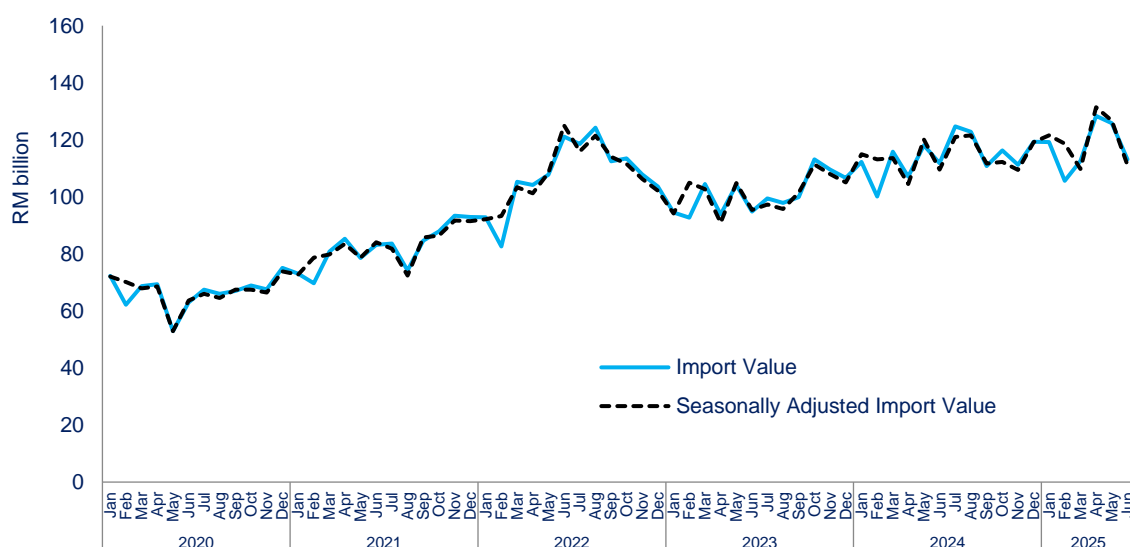


Chart 7: Actual Import Value and Seasonally Adjusted Imports Value, RM billion



Import Performance for Major Country of Origin

China and Singapore were Malaysia's two major country of origin in June 2025, accounting for 35.1 per cent of total imports.

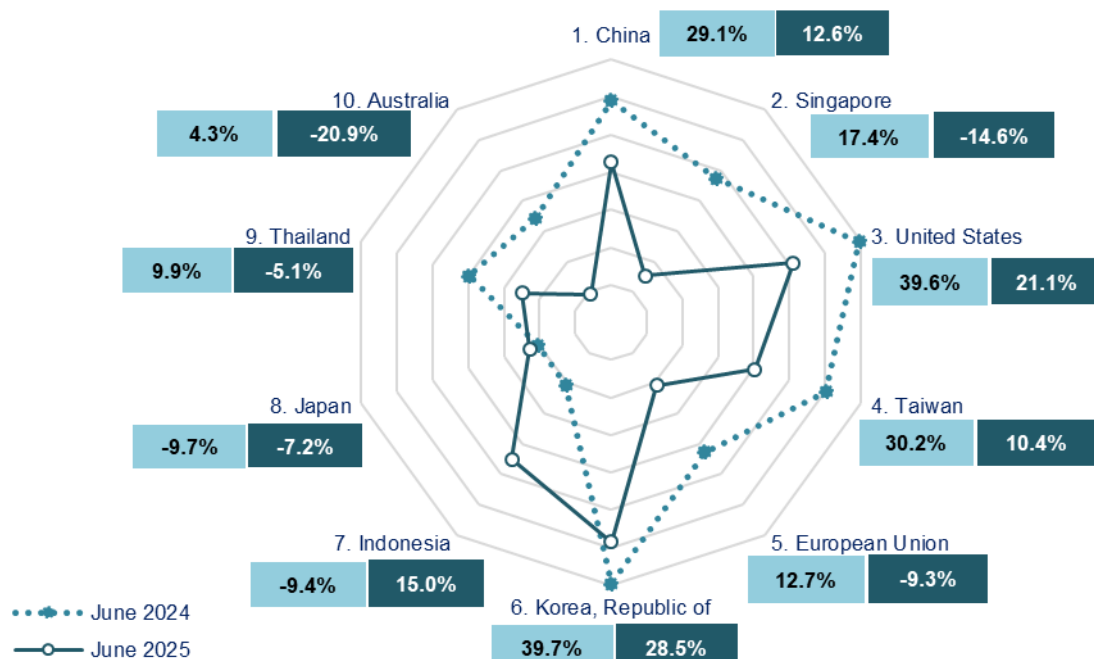
Malaysia's imports from China climbed by 12.6 per cent to RM27.8 billion, accounting for 24.6 per cent of total imports. This growth is driven by petroleum products which gained a 95.4 per cent increase (+RM833.0 billion), followed by other manufactures (+RM454.8 million, +66.1%) and machinery, equipment & parts (+RM435.1 million, +14.6%).

Imports from Singapore were worth RM11.8 billion, accounting for 10.4 per cent of Malaysia's

imports, downed by 14.6 per cent, or RM2.0 billion, y-o-y. This diminishment was primarily driven by slower imports of petroleum products (-RM1.7 billion, -41.8%) and chemical & chemical products (-RM229.7 million, -20.4%).

Imports from the top 10 countries of origin showed an increase from China, the United States, Taiwan, the Republic of Korea, and Indonesia. However, declines were recorded for Singapore, the European Union, Japan, Thailand, and Australia compared to the same period last year.

Chart 8: Annual Change for Imports for Major Country of Origin, June 2024 and June 2025



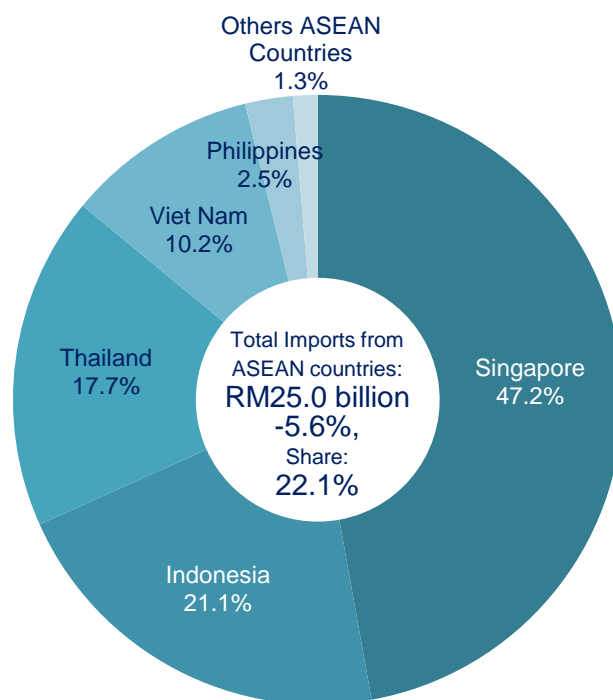
Imports from ASEAN Countries

Imports from ASEAN countries fell by 5.6 per cent in June 2025, reaching RM25.0 billion. It accounted for 22.1 per cent of Malaysia's overall imports. This is driven from slower imports of petroleum products (-RM2.1 billion, -41.6%), chemical & chemical products (-RM530.3 million, -25.4%) and

transport equipment (-RM277.3 million, -28.9%).

Imports from Singapore remained the largest among ASEAN countries, despite recording a decline of 14.6 per cent (-RM2.0 billion) compared to the previous year, contributing 47.2 per cent to total ASEAN imports.

Import Performance for Economic Sectors

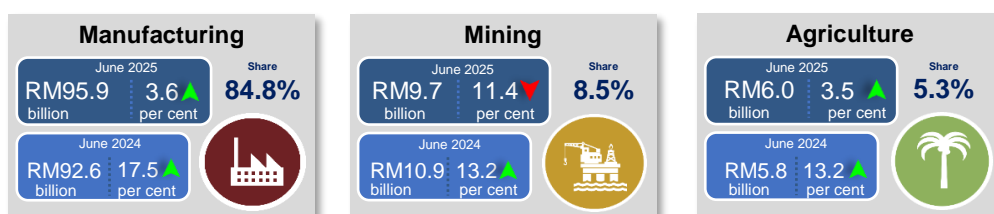
Manufactured goods, accounting for 84.8 per cent of overall imports, grew by 3.6 per cent from RM92.6 billion to RM95.9 billion, y-o-y. This performance was driven by increased imports of E&E products (+RM3.8 billion, +10.5%); machinery, equipment & parts (+RM1.4 billion, +15.3%); and other manufactures (+RM820.9 million, +37.4%).

Imports of agricultural products (5.3% of total imports) increased 3.5 per cent (+RM198.9 million), y-o-y, to RM6.0 billion, boosted by higher imports of palm oil & palm-based agriculture

products (+RM147.4 million, +42.7%), seafood, fresh, chilled or frozen (+RM75.4 million, +25.9%), and other vegetables oil (+RM21.4 million, +5.3%).

However, mining imports amounted to RM9.7 billion, down 11.4 per cent from the previous year and accounting for 8.5 per cent of Malaysia's overall imports. The decrease was attributed to lower imports of crude petroleum (-RM1.7 billion, -27.8%) and liquefied natural gas (LNG) (-RM505.6 million, -43.6%).

Imports of Selected Major Products

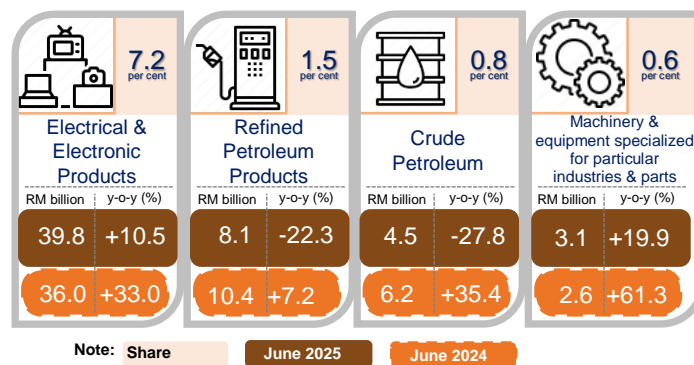
Imports performed well in June 2025, with positive growth in the following products:

- E&E products accounted for 7.2 per cent of total imports and grew by 10.5 per cent or RM3.8 billion to RM39.8 billion; and
- Machinery & equipment specific to certain industries & spare parts climbed by 19.9 per cent or RM507.8 million to RM3.1 billion, accounting for 0.6 per cent of total imports.

Meanwhile, negative growth was noted for the following products:

- Refined petroleum products accounted for 1.5 per cent of total imports, increasing by RM2.3 billion or 22.3 per cent to RM8.1 billion in line with the average unit value decreased by 23.6 per cent. While, import volume rose by 1.7 per cent; and
- Crude petroleum imports, accounting for 0.8 per cent of total imports, dropped by RM1.7 billion or 27.8 per cent to RM4.5 billion. This was in line with a decrease in average unit value (-27.1%), import volume (-0.9%) and a fall in Brent oil price by 22.0 per cent to RM303.2 per barrel.

Exhibit 4: Imports of Selected Major Product, June 2024 and June 2025



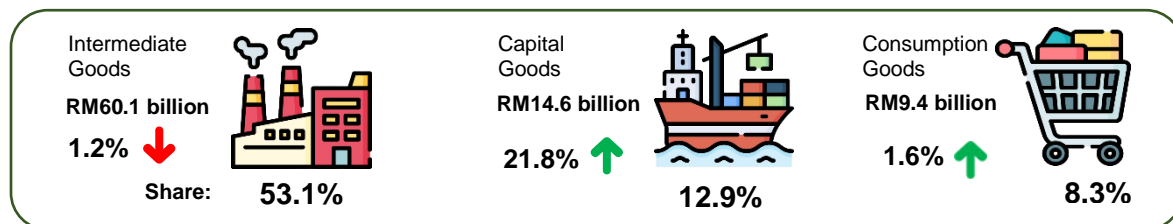
Imports for End Use & Broad Economic Categories (BEC) Classification

Total imports in June 2025 stood at RM113.1 billion, registering a year-on-year increase of 1.2 per cent. The three major categories of imports by End-use, which collectively accounted for 74.4 per cent of total imports, were:

Intermediate goods, accounting for RM60.1 billion or 53.1 per cent of total imports, decreased by 1.2 per cent. This was due to decrease in imports of fuel & lubricants, primary (-RM2.0 billion, -24.8%), industrial supplies, processed (-RM1.5 billion, -7.1%), and fuel & lubricants, processed, other (-RM1.1 billion, -32.1%).

Capital goods, climbed by 21.8 per cent to RM14.6 billion (12.9 per cent of total imports), with higher imports of capital goods (except transport equipment) up by 25.6 per cent reaching RM13.7 billion.

Consumption goods, increased by 1.6 per cent to RM9.4 billion (8.3 per cent of total imports), due to higher imports of durables goods (+RM268.0 million, +18.0 %).
